# B. EXPLANATORY NOTES PURSUANT TO PARAGRAPH 9.22 AND PART A OF APPENDIX 9B OF THE LISTING REQUIREMENT OF BURSA SECURITIES

#### **B1.** Review of Performance

#### **Current Year Quarter:**

The Group achieved a revenue of RM104 million for the quarter under review. The revenue decreased by RM69 million or 40% as compared to the same quarter last year. The decrease is mainly due to the lower progress billings recognized from the ongoing projects as a result of the implementation of MCO and CMCO commencing from 18 March 2020.

In line with the lower revenue, the Group registered a loss before tax of RM9.9 million for the quarter. The loss before tax is also due to the one-off impairment of Industrialised Building System ("IBS") equipment amounting to RM3.9 million.

#### Current Year To Date:

The Group achieved a revenue of RM277 million for the period ended 30 June 2020 with majority contribution from the construction division. The revenue decreased marginally by RM20 million or 7% as compared to the same period last year.

In line with the lower revenue, the Group registered a loss before tax of RM6.1 million for the period ended 30 June 2019 as compared to profit before tax of RM14.7 million in the same period last year. The loss before tax is mainly due to the lower progress billings as a result of the implementation of MCO and CMCO as well as the one-off impairment of IBS equipment amounting to RM3.9 million.

The revenue decreased by 40% due mainly to the lower construction progress recognized from the ongoing projects as a result of the implementation of MCO and CMCO.

In line with the lower revenue, the Group registered a loss before tax of RM9.9 million for the quarter. The loss before tax is also due to the one-off impairment of IBS equipment amounting to RM3.9 million.

#### B3. Prospects for the Financial Year ending 31 December 2020

As at 30 June 2020, the Group has an outstanding order book of RM1.3 billion, comprising 9 ongoing projects. These projects are expected to continue to contribute construction income for the financial year ending 31 December 2020. In addition, the concessionaire and maintenance income, which was not affected by the MCO and CMCO, will provide consistent contribution for the remaining period of year 2020.

However, there are still uncertainties arising from the COVID-19 pandemic. This may affect the performance of the Group for the rest of the year.
